

## Report on the Firm's System of Quality Control

To the Shareholders of Hungerford Nichols and the National Peer Review Committee

We have reviewed the system of quality control for the accounting and auditing practice of Hungerford Nichols (the firm) in effect for the year ended February 28, 2020. ### Peer Reviewer's Responsibility

Our responsibility is to express an opinion on the design of the system of quality control and the firm's compliance therewith based on our review.

#### **Required Selections and Considerations**

Engagements selected for review included engagements performed under *Government Auditing Standards*, including compliance audits under the Single Audit Act; and audits of employee benefit plans.

As a part of our peer review, we considered reviews by regulatory entities as communicated by the firm, if applicable, in determining the nature and extent of our procedures.

# Opinion

In our opinion, the system of quality control for the accounting and auditing practice of Hungerford Nichols in effect for the year ended February 28, 2020, has been suitably designed and complied with to provide the firm with reasonable assurance of performing and reporting in conformity with applicable professional standards in all material respects.
